



Terms and conditions of contract with www.costadejalisco.com

1. The website www.costadejalisco.com is designed and maintained by Experience Mex-ECO Tours S.A. de C.V. Our office is at Gomez Farías #59-2, San Patricio Melaque, Jalisco. C.P. 48980, Mexico.
2. The website, www.costadejalisco.com is an advertising site for businesses and services on the coast of Jalisco in order to attract more people to the area and improve information available to both locals and visitors. Clients pay to advertise on the website, and all clients will be offered the same service.
3. Experience Mex-ECO Tours S.A. de C.V. reserves the right to refuse a request from a potential client to advertise on www.costadejalisco.com.
4. The client must fully understand what is included in the internet advertising package he/she has selected.
5. Each contract is for one year, shorter terms are not available. In order to reserve a place for a subsequent year, a 50% deposit must be made, and a deadline set for full payment.
6. **Payment must be made in full before the clients information is uploaded to the website.** If the client wishes to make a 50% deposit to reserve the advertising package, then a deadline for full payment must be agreed upon and noted on the receipt (of which the client keeps one copy).
7. **No refunds will be made once a payment has been made**, unless www.costadejalisco.com reserves a particular banner space for more than one client at any one time; in which case the second client to have made the payment will be fully refunded. Where there is no error on the part of www.costadejalisco.com, deposits will not be refunded if the client does not make his/her full payment by the deadline and payments will not be refunded if the client fails to give the relevant information for his/her advertisement by the deadline.
8. The start and end date of the contract must be clearly noted on the receipt (of which the client keeps one copy).
9. In the case of banner advertising; if another client asks about reserving a space after the client currently renting that space finishes his/her contract, then the current client will be given the option of paying the 50% deposit to continue with the space for an extra year; if rejected then the new client may make the 50% deposit and reserve that space. Such deposits will not be refunded, and if the client then does not make the rest of the payment by the deadline the banner space will be offered to other clients.
10. Prices do not include I.V.A., and for clients requiring an official receipt (factura), an extra charge of 15% of the total will be added.
11. In the event of www.costadejalisco.com becoming inactive, no more payments will be taken from clients, and any clients who still have four months or more left of their contract will be given a refund for the number of months remaining on that contract.

12. The speed of upload of the website depends on the total size of the files associated with the website, and the speed of internet connection on the computer being used to view the site. No refunds or contract extensions will be given for slow upload speed unless there has been an error on the part of www.costadejalisco.com.
13. Links to external websites will be uploaded as given by the client, failure for that link to work (e.g. in the event of deactivation of that site) is not the responsibility of www.costadejalisco.com.
14. Each client will receive a notice via E-mail (where available) two months before their advertising package is due to expire, and again one month before their advertising package is due to expire. At this time the client will be informed of any inflation or deflation in prices and given the option to continue or terminate their contract on expiration of current contract.
15. Payment must be made in cash, cheque or bank deposit; cheques and bank deposits must be made to '**Experience Mex-Eco Tours S.A. de C.V.**' Payment by cheque must include the 15% I.V.A. charge and a factura must be issued.
16. Any changes that a client wishes to make to his/her information on the website within the year long contract are not included in the original fee, and are quoted separately. However, on renewal of contracts, a client may provide new or updated information which is included in the yearly fee.
17. The official start date for all clients who purchase an advertising package before 1st October 2008 is 1st October 2008. Therefore, any clients making their payment before this date will receive free advertising leading up to this date, and their contracts will be renewed on 1st October 2009 upon renewal of payment.
18. All other contracts begin 10 days from the date of payment, allowing time for client information to be uploaded to the website. In some cases this information may be uploaded earlier, yet the contract will still begin on the date stated on the receipt. In some cases, this 10 day period for information upload may be extended to 14 days by www.costadejalisco.com, in which case the start date of the contract will also be extended.
19. www.costadejalisco.com is not responsible for passing on enquiries about a business/service generated from the website. Clients wishing to use the site as a form of enabling reservations/enquiries online must come to a separate agreement with Experience Mex-Eco Tours S.A. de C.V.
